However, we recognize that the school reserves the right to suspend, expel or otherwise discipline any student who fails to adhere to the standards set forth in the Parent/Student Handbook.

We understand that Mt. Bethel Christian Academy is a non-profit ministry of Mt. Bethel United Methodist Church operating on the principle of faith. Tuition levels are designed to make Christian education available to as many people as possible. Because tuition does not cover all the costs associated with the education of our child, the Fund for Excellence has been established to assist the school in major capital outlays. We pledge to support the Fund for Excellence as God blesses our family financially. Furthermore we pledge to consistently pray for the Board, Administration, Teachers and Students of the school on a regular basis.
